General Golf Membership

Monthly Dues \$420
Initiation Fee \$5,000

A General Golf membership provides the member and their immediate family full use of the golf, tennis, swimming and clubhouse facilities at Oak Hills upon payment of applicable dues, fees and other charges established by the Club. General Golf members are not charged green fees. General Golf members are required to pay annual mandatory fees and meet an annual food minimum. General Golf members have full voting rights.

Corporate Golf Membership

Monthly Dues \$420
Initiation Fee \$5,000

A Corporate Golf membership is held in the name of a corporation, partnership, trust or other legal entity, with one person designated as the member who is a legitimate, full-time employee. The member, along with their immediate family, are provided full use of the golf, tennis, swimming and clubhouse facilities at Oak Hills upon payment of applicable dues, fees and other charges established by the Club. Golf members are not charged green fees. Corporate Golf members are required to pay annual mandatory fees and meet an annual food minimum. The designated person has full voting rights.

The Corporate Golf membership can be reassigned by the entity for a fee.

Corporate Golf Plus Membership

Monthly Dues \$420
Initiation Fee Waived

A Corporate Golf member may add additional legitimate, full-time employees, up to five (5), to the Corporate Golf membership. The Corporate Golf Plus membership is only active as long as the initial Corporate Golf membership is current and active. The additional employee and their immediate family members have full use of the golf, tennis, swimming and clubhouse facilities at Oak Hills upon payment of applicable dues, fees and other charges established by the Club. Corporate Golf Plus members are required to pay annual mandatory fees and meet an annual food minimum. Corporate Golf Plus members do not have voting rights and cannot serve on the Board of Directors or any member committee. Tee-time availability is weekdays anytime, but restricted to after 12 p.m. on weekends and holidays.

The Corporate Golf Plus members may be reassigned, once per year per additional member.

Senior Golf Membership

Monthly Dues \$315

Initiation Fee Waived

A Senior Golf membership is available to individuals who have been a General Golf member at Oak Hills for at least five years and is at least 65 years of age. This membership provides the senior golf member and their immediate family to play golf during weekdays and Saturday and Sundays after 3 p.m. This membership also provides full access of the tennis, swimming and clubhouse facilities at Oak Hills upon payment of applicable dues, fees, and other charges established by the Club. Senior Golf members are required to pay annual mandatory fees and meet an annual food minimum. Golf members are not charged green fees. The Senior Golf member does not have voting rights.

Young Professional Golf Membership

Monthly Dues \$315

Initiation Fee \$3,000

A Young Professional Golf membership is offered to individuals 25 to 34 years of age, and provides the member and their immediate family full use of the golf, tennis, swimming and clubhouse facilities at Oak Hills upon payment of applicable dues, fees and other charges established by the Club. Young Professional Golf members are required to pay annual mandatory fees and meet an annual food minimum. Golf members are not charged green fees. At the age of 35, the member must re-classify to a General Golf membership, but are not required to pay the difference in initiation fees.

Non-resident Golf Membership

Monthly Dues \$315

Initiation Fee \$1,000

A Non-resident Golf membership is offered to those who live outside of a 50-mile radius of the Club, and provides the member and their immediate family full use of the golf, tennis, swimming and clubhouse facilities at Oak Hills upon payment of applicable dues, fees and other charges established by the Club. Non-resident Golf members are not required to pay the mandatory fees and do not have any minimums. Golf members are not charged green fees.

Second Club Golf Membership

Monthly Dues \$210

Initiation Fee \$1,000

A Second Club Golf membership is offered to individuals who hold and maintain a primary golf membership at a greater Omaha metro private country club with dues equal or greater than the General Golf member monthly dues at Oak Hills. The membership provides the member and their immediate family full use of the golf, tennis, swimming, and clubhouse facilities at Oak Hills upon payment of applicable dues, fees and other charges established by the Club. Golf members are not charged green fees.

Social Membership

Monthly Dues \$125

Initiation Fee \$1,500

A Social Membership is offered and provides the member and their immediate family full use of the tennis, swimming and clubhouse facilities at Oak Hills upon payment of applicable dues, fees and other charges established by the Club. Social members are required to meet an annual food minimum. Social members have limited access to the golf facilities and are permitted to golf four (4) times per year on weekdays.

Senior Social Membership

Monthly Dues \$110

Initiation Fee Waived

A Senior Social membership is offered to individuals who have reached at least 65 years of age and provides the member and their immediate family full use of the tennis, swimming and clubhouse facilities at Oak Hills upon payment of applicable dues, fees and other charges established by the Club. Senior Social members are required to meet an annual food minimum.
